AFFIDAVIT

I, the undersigned applicant, being duly sworn, hereby attest that the statements made on this "Bonding Agency Application and Affidavit" are true. I shall promptly notify the court in writing of any change of information contained in this application.

I will not sell, assign away, mortgage or encumber any of the assets listed in my affidavit without first notifying the then-Chief Judge of the Lenawee County Circuit Court, in writing, of such intent.

I will, at no time, become obligated upon bonds in an amount in excess of an amount to be established by the Chief Judge at the time of his or her approval to act as a bondsman. This shall include and apply to bonds written in Lenawee County as well as elsewhere.

I authorize any bank, stock brokerage firm, or credit exchange to freely and fully disclose to the Chief Judge or his or her agent any information possessed by such parties regarding the applicant and his or her assets and liabilities.

I understand that a current affidavit containing the above information and attachments must be filed with the Chief Judge of the Lenawee County Circuit Court on or before December 20 of each year by those persons wishing to remain on the list of approved bondspersons.

I understand that agents of an approved bondsman are authorized to sign recognizances under a power of attorney when said document includes the proviso that such attorney-in-fact is authorized to bind his principal in a sum not to exceed the amounts listed above until said principal delivers to the Chief Judge a written revocation of the power of attorney.
